The Company has the option to repair, re-instate or replace the vehicle or part thereof and/or its accessories or may pay in cash the amount of loss or damage. The Liability of the Company shall not exceed:</p> <p>i. For total loss/constructive total loss of the vehicle - the Insured Declared Value of the vehicle (including accessories) after deducting the value of wreck.</p> <p>ii. For partial losses, i.e. losses other than total loss/constructive total loss of the vehicle - actual and reasonable costs of repair and/or replacement of parts lost/damaged subject to deduction of depreciation as per limit specified. No Claim Bonus (NCB) No Claim Bonus (NCB) can be earned only in the Own Damage section of Policies covering all classes of vehicles but not on Motor Trade Policies (Road Transit Risks / Road Risks / Internal Risks) and policies which cover only Fire and / or Theft Risks. For policies covering Liability with Fire and/or Theft Risks, the NCB will be applicable only on the Fire and / or Theft components of the premium. An insured becomes entitled to NCB only at the renewal of a policy after the expiry of the full duration of 12 months.</p> <p>For Long term policies, No Claim Bonus will be as per the following table:</p>

However, the insured can at the inception of the policy, opt to restrict to the TPPD cover to the statutory limit of ₹6,000/- as provided in the M. V. Act.
