The Company has the option to repair, re-instate or replace the vehicle or part thereof and/or its accessories or may pay in cash the amount of loss or damage. Change of Vehicle/Sale of Vehicle A vehicle insured under a policy can be substituted by another vehicle of the same class for the balance period of the policy subject to adjustment of premium, if any, on pro-rata basis from the date of substitution. Where the vehicle so substituted is not a total loss, evidence in support of continuation of insurance on the substituted vehicle is required to be submitted to the Company before such substitution can be carried out.</p> <p>3. Cancellation and Issuance of fresh Certificate of Insurance Any changes in the policy during its currency, affecting the information shown on the Certificate of Insurance, the Certificate of Insurance is required to be returned to the Company for cancellation and a fresh Certificate incorporating the changes is to be issued. Remittance of ₹50/- is required to be made to the Company for each issuance of fresh Certificate of Insurance The Policy can be cancelled by the Insured at any time by sending a seven day's notice and shall be refunded on Company's short period scale, if no claim under the policy has been made. If the Company cancels the policy by sending a seven day's notice on the grounds of misrepresentation, fraud, non-disclosure of material facts or non-cooperation, refund will be made on pro-rata basis.</p> <p>4. Third Party Property Damage (TPPD) Cover Limit of cover for Third Party Property Damage (other than for goods carried in the insured vehicle) under Liability Only policies and under Section II – 1(iii) of Commercial Vehicle insurance is ₹7.5 Lakh. However, the insured can at the inception of the policy, opt to restrict to the TPPD cover to the statutory limit of ₹6,000/- as provided in the M. V. Act.
